**08/12/2013** 11:38 AM | Email to Lehigh Transition Services. Emilie has skin fissures from undiagnosed and cultivated Norwegian Scabies. Prone to infection and septic shock. She was assigned unprecedented stray animal cage cleaning duty. There were so many deep raw cracks—her hands were being held together with tape. They were murdering her. 2.86.31, 1.5.6

08/20/2013 TUESDAY FRIED FRANK ASSIGNED HOLIDAY CARD PROJECT.

08/23/2013 Friday e-mail from federal guardian Shannon Moore that Emilie was doing great in her transition to SPIN. Emilie is almost dead. [2.86.34](#)

08/23/2013 EMILIE IS NEAR DEAD FROM NORWEGIAN SCABIES.

08/24/2013 Saturday morning: Emilie can barley walk — there is an abundance of fluid on the bottom of her foot her mother called “juice”. It was highly likely a staph infection from undiagnosed Norwegian scabies her mother knew she had.

**09/11/2013** Fuchsberg Law Firm made mindless corrections to his website. [4.16.1](#)

09/12/2013 Mother Amy DeRaymond's got unprecedented monthly combination of brain damaging psychotropic pharmaceuticals known to lower the threshold for seizures to occur. [4.16](#)

**09/13/2013** FRIED FRANK SELECTED ME FOR PRODUCTION OF THEIR HOLIDAY CARD.

**11/01/2013** I refused to pay disability support after Emilie's mother attempted to murder her. I end what is a silent extortion agreement. [2.82](#)

**11/04/2013** 20th Precinct Inspector McGinn was promoted, R&R were bribing McGinn and had significant influence over NYPD leadership promotions. My apartment was turned into a death trap. [1.11](#)

**02/24/2014** Northampton County Judge Roscioli | Overnight answer disability support hearing #16690 scheduled for 02/26/2014. It states 05/18/2006 Pennsylvania's Special Education Appeals Panel Opinion No.1727 upheld my daughter's pendent diagnosis PDD-NOS AND the rejection of diagnosis MR317 submitted by the Mother Amy DeRaymond. Northampton County MH/MR ignored the appeals panel and

treated Emilie for mental retardation MR317 since 03/28/2006 and was asking for disability support for MR317 when my daughter should have been attending college.

#### **03/26/2014 JUDGE ED SMITH APPOINTED FEDERAL JUDGE**

**03/27/2014** Mother Amy Fontno, Lisa Spitale, and Dr. Cha Yu quadrupled my daughter's medication of Risperidone to 105 tablets. Previously they were monthly dosages of 30 tablets. The overdose Brian damaged Emilie causing her to convulse.

**03/27/2014** Freya Koger, Director of Lehigh Transition Services and federal guardian Shanon Moore hid the detrimental effects of Emilie's overdose caused by her mother Amy DeRaymond and guardian Lisa Spitale in Emilie's progress report.

**05/18/2014** Emilie's federal guardian Shanon Moore quit.

**05/23/2014 FRIDAY MEETING WITH FRIED FRANK ATTORNEYS FOR FINAL PAYMENT.**

Attorney asked about my 05/23/2014 meeting with Federal Judge Rice Philadelphia to appoint a new federal guardian. [Lisa Spitale was used to protect Ed Smith's appointment] FF is quite aware of my Smith connection and pulled the plug. Leaving only Pitta who was orchestrating this.

I told the other attorney also present that it was NOT in my or daughter's interest and a huge conflict of interest to meet Federal Judge Rice. That Judge Tim Rice ought to have recused himself since I sued him in 2010 and could not be impartial. She agreed.

**05/23/2014** Friday Federal Judge Timothy Rice replaced Emilie's federal guardian Shanon Moore with Lisa Spitale responsible for torturing my daughter. Moore quit a few days after I opened SDNY 14-cv-3804 Kraemer v. Edelstein [4.16](#).

**05/25/2014** Sunday Emilie was overdosed into **convulsions** with 126 tablets of Risperidone with a prescription by Dr. Cha Yu, approved by federal guardian Lisa Spitale.

Lehigh Transition Services released a report a few days later that Emilie's cognitive retention **improved by 30% to 40% points** after deliberately brain damaging her:
